## What is Manzanar?

During WWII, more than 120,000 people of Japanese descent were incarcerated in concentration camps, stripped of their livelihood and property by the US government.

# Who is a "No-No" Boy?

The US Government evaluated the "loyalty" of incarcerated Japanese, with a questionnaire. "No-No boys" were those who answered "No" to questions 27 and 28. Those questions were as follows:

#### Question 27:

Are you willing to serve in the armed forces of the United States on combat duty wherever ordered?

#### Question 28:

Will you swear unqualified allegiance to the United States of America and faithfully defend the United States from any or all attack by foreign or domestic forces, and forswear any form of allegiance or obedience to the Japanese emperor, to any other foreign government, power or organization?

# Concept



Show through conversation the frustration of a man who was asked to risk his life for a country that failed him. Show through conversation, the frustration of a man who was asked to forswear allegiance to an emperor he never knew.

We will achieve this through a three minute conversational vignette set in Manzanar in 1943, between the user, and a digital "No-No Boy".

# A Three Minute Conversation


*The user* is a fictional WRA (War Relocation Authority) agent, asking *Ichiro Yamada* (*Powered by InworldAI*), to clarify some of his answers he gave in the "War Relocation Authority Application for Leave Clearance". *Ichiro* had left some answers blank. A calm and collected Ichiro enters the room, and *the user* will be given the opportunity to ask the questions that were left blank.

When we arrive at questions 27 and 28. *Ichiro* becomes visibly irritated, his tone frustrated and heated, as he gives his reasons of why his answers are "No" and "No". The experience ends only when *the user* orders *Ichiro* be sent to Tule Lake for being "disloyal". *The user* will bear responsibility in destroying what little semblance of normalcy *Ichiro* has built in Manzanar.











#### Conversation Logic: Error Handling



Selected Excerpts: User fills out "No" for question 28 in the questionnaire when the user hasn't asked the question yet (Assumption experience)



#### "Escape Hatches":

E.g. when user asks too many questions, Ichiro will interrupt and ask the user to stay on topic.

2.3 Force Question Ask Experience	User hasn't asked the questions yet.	Can you stop wasting my time? Please just read out the question please.
